Indian Institute of Astrophysics (IIA) is an autonomous academic national institution under Department of Science & Technology, Govt. of India dedicated to research in Astronomy, Astrophysics and Allied Sciences & Technology. The Institute has its main campus in Koramangala, Bengaluru and CREST Campus at Hosakote, Bengaluru. It operates field stations at Kavalur & Kodaikanal in Tamil Nadu, Gauribidanur in Karnataka, and Leh/Hanle in Union Territory of Ladakh.

Online applications are invited from eligible, young, bright and highly motivated individuals for the following position to work at Vainu Bappu Observatory (VBO), Kavalur.

**Job Description:** The selected candidate should discharge the following responsibilities which include but not limited to:

The positions are for carrying out astronomical observations with telescopes at night. The candidates should be fit enough and willing to work full night (up to 12 hours).

## **Terms & Conditions:**

1. The appointment is purely temporary on contract basis and does not confer any privilege or benefit applicable to regular employment. No claim whatsoever for regular employment in the Institute shall be entertained.
2. The tenure of traineeship is for a period of one year and extendable annually for four years (Total five years of traineeship) subject to satisfactory performance of the candidate and requirement to the Project assessed annually. You are liable to be posted anywhere in India as per the requirement of the Institute.
3. There will be annual increase of Rs. 2,500/- in the remuneration based on satisfactory performance.
4. The date of determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed applications.
5. It is open to the Institute to conduct written test to shortlist the candidates for interview in case the attendance of candidates is more.
6. Age relaxation is permissible to SC, ST & OBC candidates and also to physically handicapped candidate as notified by Government of India from time to time.
7. The incumbent candidate will be posted to work in VBO, Kavalur and is liable to be posted anywhere in India as per the requirement of the Institute/Project.
8. NO TA/DA will be reimbursed to the shortlisted candidates for attending Interview/Skill Test.
9. No correspondence will be entertained with the candidates not selected for interview/appointment. Canvassing in any form will be a disqualification.
10. Candidates of Indian Nationality only can apply for this post.
11. The prescribed educational qualifications are minimum required, and mere possession of the same does not entitle candidates to be called for interview.
