- 4. The applicant is required to pay a non-refundable application fee of ₹500/- (Rupees Five Hundred only) through online for each post applied. For claiming such exemptions, the applicant has to submit a self-attested copy of latest SC/ ST/ PwD/Transgender certificate/Identity Proof/ Discharge Certificate as applicable. - 7. The candidates applying for any post should ensure that they fulfill all the eligibility criteria and conditions for the post. Their admission to any stage of the selection process will be purely provisional subject to confirmation that they satisfy the prescribed eligibility conditions. Mere issue of call letter to the candidate for attending the selection test will not imply that his/her candidature has been found eligible.
- 8. Age relaxation will be provided to the specified categories as per Govt. of India norms as applicable from time to time.
